Application Notes for Dasan DSU-11M USB QD Connector Cable and SoftLink software with Avaya one-X® Agent - Issue 1.1

Abstract

These Application Notes describe the configuration steps required to integrate the Dasan DSU-11M USB QD Connector Cable and SoftLink software with Avaya one-X® Agent. In this compliance test, a Dasan Freemate DH series headset is used to connect to DSU-11M Connector Cable which in turn connects to the PC via USB cable. SoftLink is a collection of programs that enable remote call control with Dasan Freemate DH series headsets and Avaya one-X® Agent. With a Dasan Freemate DH Series headset connected via DSU-11M Connector Cable to the USB interface on a PC, users can directly answer, end, mute/unmute calls and adjust speaking volume using buttons on the Dasan cable.

Readers should pay attention to **Section 2**, in particular the scope of testing as outlined in **Section 2.1** as well as any observations noted in **Section 2.2**, to ensure that their own use cases are adequately covered by this scope and results.

Information in these Application Notes has been obtained through DevConnect compliance testing and additional technical discussions. Testing was conducted via the DevConnect Program at the Avaya Solution and Interoperability Test Lab.

1. Introduction

The DSU-11M USB QD Connector Cable together with SoftLink software allow connection and call control with Avaya one-X® Agent (hereafter referred to as one-X Agent) via USB cable to a PC. In this compliance test, a Dasan Freemate DH Series headset is used to connect to the DSU-11M Connector Cable. SoftLink is a collection of programs that enable remote call control with Dasan Freemate DH Series headsets and Avaya one-X® Agent. With a Dasan Freemate DH Series headset connected via DSU-11M Connector Cable to a USB port on a PC, users can directly answer, end, mute/unmute calls and adjust speaking volume using buttons on the DSU-11M USB QD Connector Cable.

The DSU-11M USB QD Connector Cable can be used with other Dasan headsets, as detailed in Attachment 1. For additional information or support, contact information is provided in section 2.3.

2. General Test Approach and Test Results

The interoperability compliance test included feature and serviceability testing. The feature testing focused on placing calls with one-X Agent, answering and ending calls using the call control button on the cable, and verifying two-way audio. The call types included calls to voicemail, local extensions, and the PSTN. Call hold and resume, mute and un-mute are also tested.

The serviceability testing focused on verifying the usability of the Dasan headset solution after restarting the one-X Agent, restarting the PC and reconnecting the USB cable of the base to the PC.

DevConnect Compliance Testing is conducted jointly by Avaya and DevConnect members. The jointly-defined test plan focuses on exercising APIs and/or standards-based interfaces pertinent to the interoperability of the tested products and their functionalities. DevConnect Compliance Testing is not intended to substitute full product performance or feature testing performed by DevConnect members, nor is it to be construed as an endorsement by Avaya of the suitability or completeness of a DevConnect member's solution

For the testing associated with these Application Notes, the interface between Avaya systems and endpoints utilized enabled capabilities of TLS/SRTP.

Avaya may conduct testing of non-Avaya headset/handset to determine interoperability with Avaya phones. Since there is no industry standard for handset interfaces, different manufacturers utilize different handset/headset interfaces with their telephones. 2.1. Interoperability Compliance Testing

All test cases were performed manually. The following features were verified:

- Placing calls to the voicemail system. Voice messages were recorded and played back to verify that the playback volume and recording level were good.
- Placing calls to internal extensions to verify two-way audio.
- Placing calls to the PSTN to verify two-way audio.
- Answering and ending calls using the call button on the DSU-11M cable and the soft button on one-X Agent.
- Using the soft button on one-X Agent to hold and resume the audio.
- Using the volume buttons on the DSU-11M cable to adjust the speaking volume.
- Using the mute button on the DSU-11M cable and the soft button on one-X Agent to mute and un-mute the audio.
- Verifying incoming call notification on DSU-11M cable.
- Verifying call ended notification on DSU-11M cable.

The serviceability testing focused on verifying the usability of the Dasan headset solution after restarting the one-X Agent and restarting the PC, reconnecting the USB cable to the PC.

2.2. Test Results

All test cases were completed successfully.

3. Reference Configuration




Figure 1: Test Configuration

Figure 1 illustrates the test configuration used to verify the DSU-11M USB QD connector cable and SoftLink software with Avaya one-X® Agent. The configuration consists of Avaya Aura® Communication Manager running on a virtualized server with an Avaya G450 Media Gateway providing connectivity to the PSTN via a simulated public trunk (not shown). Avaya Aura® Messaging was used as the voicemail system. Avaya Aura® Media Server provides the audio media processing. The SoftLink software was installed on the PC. Dasan Freemate DH Series headsets are connected via a DSU-11M USB QD connector cable to the USB port of the PC.

5. Configure Avaya Aura® Communication Manager

This section covers the station configuration for one-X Agent. The configuration is performed via the System Access Terminal (SAT) on Communication Manager.

Use the **add station** command to create a station for one-X Agent. Set the **Type** field to the station type to be emulated. In this example, 9641G was used. Set the **Port** field to IP and configure a **Security Code**, which will be used as the password by one-X Agent to log in. Set the **IP Softphone** field to y.



On **Page 4** of the Station form, configure the additional feature buttons shown in bold, which are used by one-X Agent to log in as an Automatic Call Distribution (ACD) agent.



6. Configure Avaya one-X® Agent

Before configuring one-X Agent, the headset has to be configured and provisioned as in **Section** 7 first. After logging into one-X Agent, click on and then select **Agent Preferences** as shown below.



In the **Agent Preferences** window, click on **Audio** and then select the **Advanced** tab as shown below. Check that **Playback Device** and **Record Device** fields display *Headset Earphone* (DSU-11M) and *Headset Microphone* (DSU-11M), respectively.



7. Configure Dasan Freemate DH Series headset

This section covers the steps to integrate Dasan Freemate DH Series headset with one-X Agent, including:

- Installing the SoftLink software
- Connect the Dasan Freemate DH Series headset

Note: After successfully performing this procedure, the Dasan headset will be detected in one-X Agent as described in **Section 6**.

7.1. Installing the SoftLink Software

SoftLink software can be obtained from Dasan portal at:



Installation of the software is done by executing the .exe file and following the prompts.


7.2. Connect the Dasan headset

Prior to starting and configuring one-X Agent, connect the Dasan Freemate DH Series headset to the DSU-11M cable using the QD connector and in turn connect the USB end to the USB port of the PC; otherwise, one-X Agent will not detect the headset. The device drivers will be installed automatically.

Ensure that the **Sound** properties under Windows 10 Control Panel are set properly. Verify that the Dasan DSU-11M has been detected by Windows 10 and that it has been set as the default device in the **Playback** and **Recording** tabs as shown below.



Open the SoftLink program installed on the PC. Select the **Device** tab on the top menu and **Device ready for use** is shown.




8. Verification Steps

This section verifies that the DSU-11M cable and SoftLink have been successfully integrated with one-X Agent PC.

1. Verify that the DSU-11M cable and SoftLink has been successfully connected for use with one-X Agent. From the **SoftLink** program, select the **Device** tab. Verify that the

Device ready for use is displayed, and the checkbox is ticked green indicating Avaya one-X® Agent in **Ready** to be used.



- 2. Note that the **Ready** state does not mean one-X Agent is logged in. The one-X Agent application can be running without the user being logged in. Once the DSU-11M is connected to one-X Agent, verify that incoming and outgoing calls can be established with two-way audio to the headset. For incoming and outgoing calls, connect to the call by pressing the call button on the headset and adjust the speaking volume from the cable.
- 3. End the call by pressing the same call button on the cable.
- 4. Verify that the call is properly disconnected.

9. Conclusion

These Application Notes describe the configuration steps required to integrate Dasan DSU-11M USB QD Connector Cable, a Freemate DH Series headset, and SoftLink software with Avaya one-X® Agent. All test cases were completed successfully.
