# Application Notes for Jabra Direct and Jabra BIZ 1500 Mono/Duo USB-A Headset with Avaya one-X® Agent - Issue 1.0

#### **Abstract**

These Application Notes describe the configuration steps required to integrate the Jabra Direct and Jabra BIZ 1500 Mono/Duo USB-A Headset with Avaya one-X® Agent.

Readers should pay attention to **Section 2**, in particular the scope of testing as outlined in **Section 2.1** as well as any observations noted in **Section 2.2**, to ensure that their own use cases are adequately covered by this scope and results.

Information in these Application Notes has been obtained through DevConnect compliance testing and additional technical discussions. Testing was conducted via the DevConnect Program at the Avaya Solution and Interoperability Test Lab.

#### 1. Introduction

The Jabra BIZ 1500 Mono/Duo USB-A Headset together with Jabra Direct software allow connection and call control with Avaya one-X® Agent (hereafter referred to as one-X Agent) using cable via the USB interface to the PC.

The Jabra Direct is a collection of programs that enable remote call control with Jabra headset and one-X Agent. With a Jabra BIZ 1500 Mono/Duo USB-A headset connected to the PC USB interface, users can directly mute/unmute and adjust volume with the in-line call controller of the headset.

## 2. General Test Approach and Test Results

The interoperability compliance test included feature and serviceability testing. The feature testing focused on placing calls with one-X Agent, answering and ending calls, and verifying two-way audio. The call types included calls to voicemail, local extensions, and the PSTN. Call hold and resume, mute and un-mute, and volume are also tested.

The serviceability testing focused on verifying the usability of the headset solution after restarting the one-X Agent, restarting the PC, and reconnecting the headset USB cable to the PC.

DevConnect Compliance Testing is conducted jointly by Avaya and DevConnect members. The jointly-defined test plan focuses on exercising APIs and/or standards-based interfaces pertinent to the interoperability of the tested products and their functionalities. DevConnect Compliance Testing is not intended to substitute full product performance or feature testing performed by DevConnect members, nor is it to be construed as an endorsement by Avaya of the suitability or completeness of a DevConnect member's solution

Avaya recommends our customers implement Avaya solutions using appropriate security and encryption capabilities enabled by our products. For the testing associated with these Application Notes, the interface between Avaya systems and endpoints utilized enabled capabilities of TLS/SRTP.

Avaya may conduct testing of non-Avaya headset/handset to determine interoperability with Avaya phones. Since there is no industry standard for handset interfaces, different manufacturers utilize different handset/headset interfaces with their telephones. ## 2.1. Interoperability Compliance Testing

All test cases were performed manually. The following features were verified:

- Placing calls to the voicemail system. Voice messages were recorded and played back to verify that the playback volume and recording level were good.
- Placing calls to internal extensions to verify two-way audio.
- Placing calls to the PSTN to verify two-way audio.
- Answering and ending calls using the soft button on one-X Agent.
- Using the soft button on one-X Agent to hold and resume the audio.
- Using the volume buttons on the in-line controller of the headset to adjust the audio volume.
- Using the mute button on in-line controller of the headset and the soft button on one-X Agent to mute and un-mute the audio.
- Verifying incoming call notification.
- Verifying call ended notification.

The serviceability testing focused on verifying the usability of the headset solution after restarting the one-X Agent, restarting the PC, and reconnecting the headset cable to the USB interface of the PC.

#### 2.2. Test Results

All test cases passed successfully.



# 3. Reference Configuration

**Figure 1** illustrates the test configuration used to verify the Jabra Direct and Jabra BIZ 1500 Mono/Duo USB-A headset with one-X Agent. The Jabra Direct software was installed on the PC together with Avaya one-X® Agent. The Jabra headset is connected via cable into the PC USB interface.

# 5. Configure Avaya Aura® Communication Manager

This section covers the station configuration for one-X Agent. The configuration is performed via the System Access Terminal (SAT) on Communication Manager.

Use the **add station** command to create a station for one-X Agent. Set the **Type** field to the station type to be emulated. In this example, 9641G was used. Set the **Port** field to IP and configure a **Security Code**, which will be used as the password by one-X Agent to log in. Set the **IP Softphone** field to y.



On **Page 4** of the Station form, configure the additional feature buttons shown in bold, which are used by one-X Agent to log in as an Automatic Call Distribution (ACD) agent.



# 6. Configure Avaya one-X® Agent

Before configuring the one-X Agent, the headset has to be configured and provisioned as in **Section 7** first. After logging into one-X Agent, click on the menu and then select **Agent Preferences** as shown below.



In the **Agent Preferences** window, click on **Audio** in the left panel and then select the **Advanced** tab as shown below. Check that **Playback Device** and **Record Device** fields display *Jabra BIZ 1500*. Otherwise, select the device from the click down menu on the respective box.



# 7. Configure Jabra BIZ 1500 Mono/Duo USB-A headset solutions

This section covers the steps to integrate Jabra BIZ 1500 Mono/Duo USB-A headsets with one-X Agent, including:

- Installing the Jabra Direct software
- Connect the Jabra headset
- Configuring Jabra headset with Jabra Direct

**Note:** After successfully performing this procedure, the Jabra headset will be detected in one-X Agent as described in **Section 6**.


## 7.1. Installing the Jabra Direct Software

Jabra Direct software can be obtained from Jabra support portal at <a href="https://www.jabra.com/support/">https://www.jabra.com/support/</a>. Installation of the software is done through executing the setup file and following the prompt.

#### 7.2. Connect the Jabra headset


Plug the Jabra BIZ 1500 Mono/Duo USB-A cable into the USB port of the PC. The device drivers will automatically be installed.

Open the Jabra Direct program installed on the PC. Select the **Device** tab on the left menu (not shown) and **Device ready for use** is shown at the bottom left. Open the one-X Agent program and check Jabra Direct program that the **Avaya softphone** status at the bottom right in **Ready** state. Note that the **Avaya softphone** status can be in **Ready** state when one-X Agent is running but not necessary logon.



## 7.3. Configuring Jabra headset with Jabra Direct


Select the **Device** from the previous screen. Select the **SOFTPHONE** (**PC**) tab and check that **Call control with softphone** is enabled as shown below (by default). Otherwise, enabled it by sliding the button to the right and click **Apply** to save it.



# 8. Verification Steps

This section verifies that the Jabra solution has been successfully integrated with one-X Agent PC.

- 1. Open the Jabra Direct program to verify that the headset has been successfully connected to PC for use with one-X Agent running. Observed that Jabra BIZ 1500 headset is detected as detailed in **Section 7.2**.
- 2. Make incoming and outgoing calls and verify that calls can be established with two-way audio. For incoming calls, answer the call from the one-X Agent. Note that Jabra BIZ 1500 does not have an answer/end call button.
- 3. End the call from the soft button of one-X Agent.
- 4. Verify also that the headset is able to remotely control call functions mute/un-mute and adjust the volume with the in-line call controller. Similarly, verify such call control functions could be done on the one-X Agent.



## 9. Conclusion

These Application Notes describe the configuration steps required to integrate Jabra Direct and Jabra BIZ 1500 Mono/Duo USB-A Headset with Avaya one-X® Agent. All test cases were completed successfully.
