Application Notes for Jabra Direct and Evolve 75 UC Stereo Bluetooth/USB Headset with Avaya one-X® Communicator - Issue 1.0

Abstract

These Application Notes describe the configuration steps required to integrate Jabra Direct and Evolve 75 UC Stereo Bluetooth/USB headset with Avaya one-X® Communicator.

Readers should pay particular attention to the scope of testing as outlined in **Section 2.1**, as well as observations noted in **Section 2.2** to ensure that their own use cases are adequately covered by this scope and results.

Information in these Application Notes has been obtained through DevConnect compliance testing and additional technical discussions. Testing was conducted via the DevConnect Program at the Avaya Solution and Interoperability Test Lab.

1. Introduction

These Application Notes describe the steps required to integrate Jabra Direct and Evolve 75 UC Stereo Bluetooth/USB headset (Evolve 75) with Avaya one-X® Communicator. Direct is a PC application that enables Evolve 75 to have call control over soft phone applications, including Evolve 75 and one-X® Communicator respectively. Evolve 75 headset has two kinds of connection to PC, one with a provided wired USB cable and another via Link 370 Bluetooth USB dongle. Link 370 also comes with the Evolve 75 headset.

2. General Test Approach and Test Results

The interoperability compliance test included feature and serviceability testing. The testing utilized two connection methods of Evolve 75 to Direct: USB cable and USB Bluetooth dongle to test with the one-X Communicator. The feature testing focused on placing calls to and from one-X Communicator using direct application and Evolve 75 headset, answering and ending calls using the call control button on the headset, and verifying two-way audio. The call types included calls between local extensions, and with the PSTN.

The serviceability testing focused on verifying the usability of the Jabra headset solution after restarting one-X Communicator and reconnecting the Jabra headset to the PC.

DevConnect Compliance Testing is conducted jointly by Avaya and DevConnect members. The jointly-defined test plan focuses on exercising APIs and/or standards-based interfaces pertinent to the interoperability of the tested products and their functionalities. DevConnect Compliance Testing is not intended to substitute full product performance or feature testing performed by DevConnect members, nor is it to be construed as an endorsement by Avaya of the suitability or completeness of a DevConnect member's solution.

Avaya recommends our customers implement Avaya solutions using appropriate security and encryption capabilities enabled by our products. The testing referenced in these DevConnect Application Notes included the enablement of supported encryption capabilities in the Avaya products. 2.1. Interoperability Compliance Testing

All test cases were performed manually. The following features were verified:

- Placing calls to and from internal extensions to verify two-way audio.
- Placing calls to and from the PSTN and to Voicemail to verify two-way audio.
- Answering and ending calls using the call control button on the headset.
- Verifying incoming call notification on headset.
- Verifying call ended notification on headset.

For the serviceability testing, the headset was reconnected to one-X Communicator and the one-X Communicator was restarted to verify proper operation of the headset.

2.2. Test Results

All test cases were executed and passed.

3. Reference Configuration

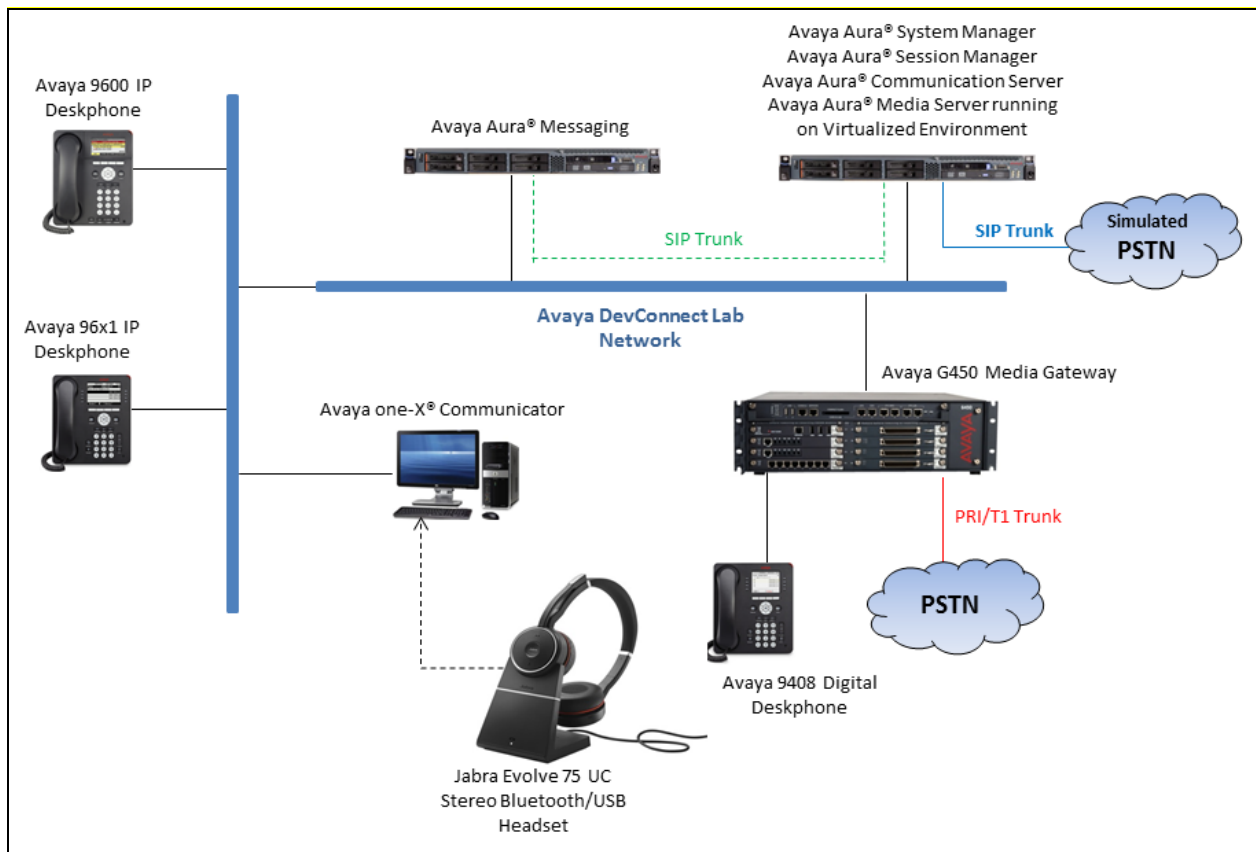


Figure 1: Test Configuration Diagram

Figure 1 illustrates a sample configuration with an Avaya SIP-based network that includes the following Avaya products:

- Avaya Aura® Communication Manager running on a virtualized environment with a Avaya G450 Media Gateway.
- Avaya Aura® Session Manager connected to Communication Manager via a SIP trunk and acting as a Registrar/Proxy for SIP telephones.
- Avaya Aura® System Manager used to configure Session Manager.

In addition, the Direct application was installed on a PC that also has the one-X Communicator soft phone installed.

5. Configure Avaya Aura® Communication Manager

Configuration and verification operations on Communication Manager illustrated in this section were all performed using Avaya Site Administrator emulation mode. The information provided in this section describes the configuration of Communication Manager for this solution. It is implied a working system is already in place, including SIP trunks to Session Manager. For all other provisioning information such as initial installation and configuration, please refer to the product documentation in **Section 10**. The configuration described in this section can be summarized as follows:

- Verify System Capacity
- Define the Dial Plan

Note: Any settings not in **Bold** in the following screen shots may be left as default.

5.1. Verify System Capacity

The license file installed on the system controls these attributes. If a required feature is not enabled or there is insufficient capacity, contact an authorized Avaya sales representative. Use the **display system-parameters customer-options** command to determine these values. On **Page 1**, verify that the **Maximum Off-PBX Telephones** allowed in the system is sufficient. One OPS station is required per one-X Communicator.

On **Page 2** of the **system-parameters customer-options form**, verify that the number of **Maximum Administered SIP Trunks** supported by the system is sufficient.

5.2. Define the Dial Plan

Use the **change dialplan analysis** command to define the dial plan used in the system. This includes all telephone extensions. In the sample configuration, telephone extensions are 4 digits long and begin with **33** and **34**.

6. Configure Avaya Aura® Session Manager

This section describes aspects of the Session Manager configuration required for one-X Communicator to register. It is assumed that the Domains, Locations, SIP entities, Entity Links, Routing Policies, Dial Patterns and Application Sequences have been configured where appropriate for Communication Manager, Session Manager and Messaging.

Session Manager is managed via System Manager. Using a web browser, access **https://<ip-addr of System Manager>/SMGR**. In the **Log On** screen, enter appropriate **User ID** and **Password** and click the **Log On** button.

6.1. Check Avaya Aura® Session Manager Ports for SIP Endpoint Registration

Each Session Manager Entity must be configured so that the SIP Endpoint can register to it. From the web interface click **Routing** → **SIP Entities** (not shown) and select the Session Manager entity used for registration. Make sure that TCP, UDP and TLS entries are present. During the compliance test, one-X Communicator registered to Session Manager using TLS transport.

6.2. Add a SIP User

A SIP user for one-X Communicator must be added. Navigate to **User Management** → **Manage Users** → **New** (not shown) and configure the following in the **Identity** tab.

- **Last Name and First Name** Enter identifying names.
- **Login Name** Enter the extension number followed by the domain, in this case **3407@bvwdev.com**.
- **Authentication Type** Select **Basic** from the drop down list.
- **Password and Confirm Password** Enter and confirm a password.

Click the **Communication Profile** tab and in the **Communication Profile Password** and **Confirm Password** fields, enter a numeric password. This will be used to register the one-X Communicator during login.

Place a tick in the **CM Endpoint Profile** check box and configure as follows:

- **System** Select the relevant Communication Manager SIP Entity from the drop down list.
- **Profile Type** Select **Endpoint** from the drop down list.
- **Extension** Enter the required extension number, in this case **3407**.
- **Template** Select **9611SIP_DEFAULT_CM_7_0** from the drop down list.
- Note that the template can be any SIP template in this example the 9611SIP used.
- **Port** The “IP” is auto filled out by the system.

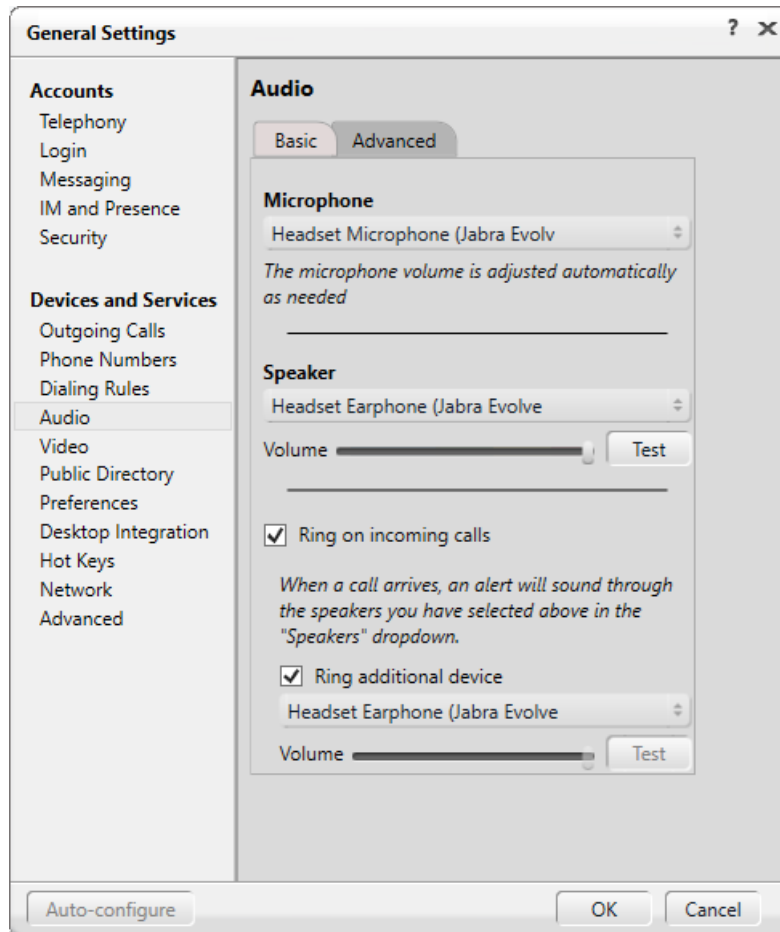

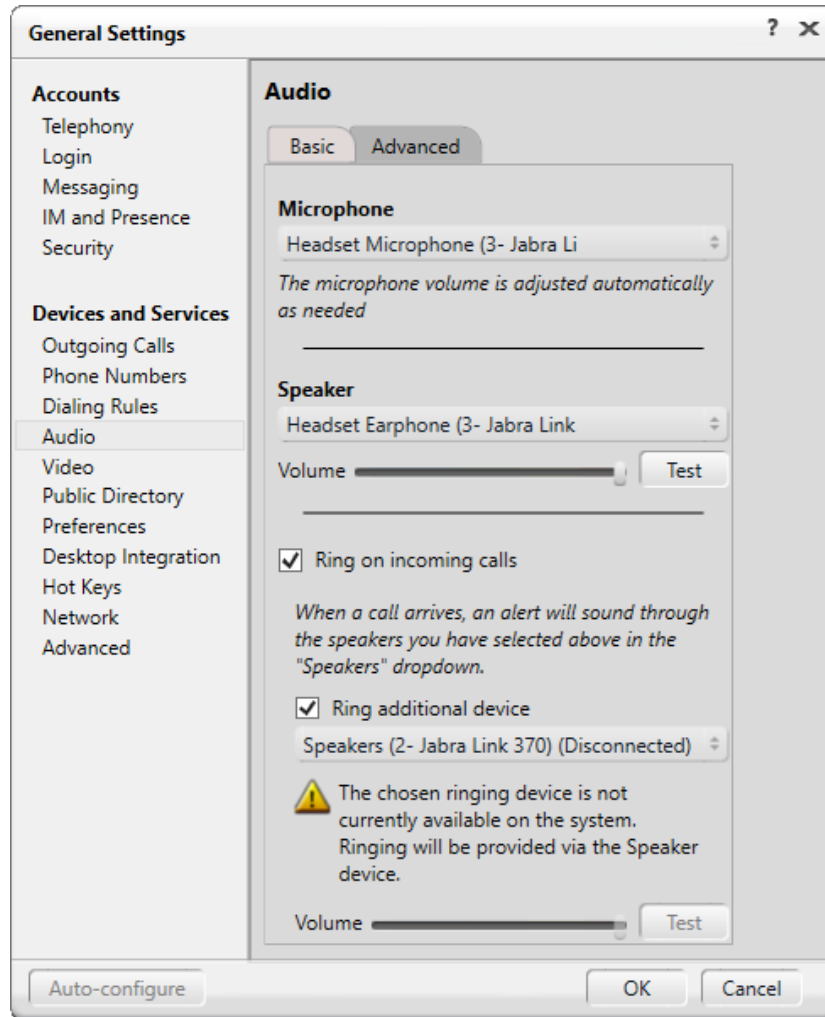
7. Configure Avaya one-X® Communicator

This section shows how to configure the Evolve 75 headset to use with the one-X Communicator.

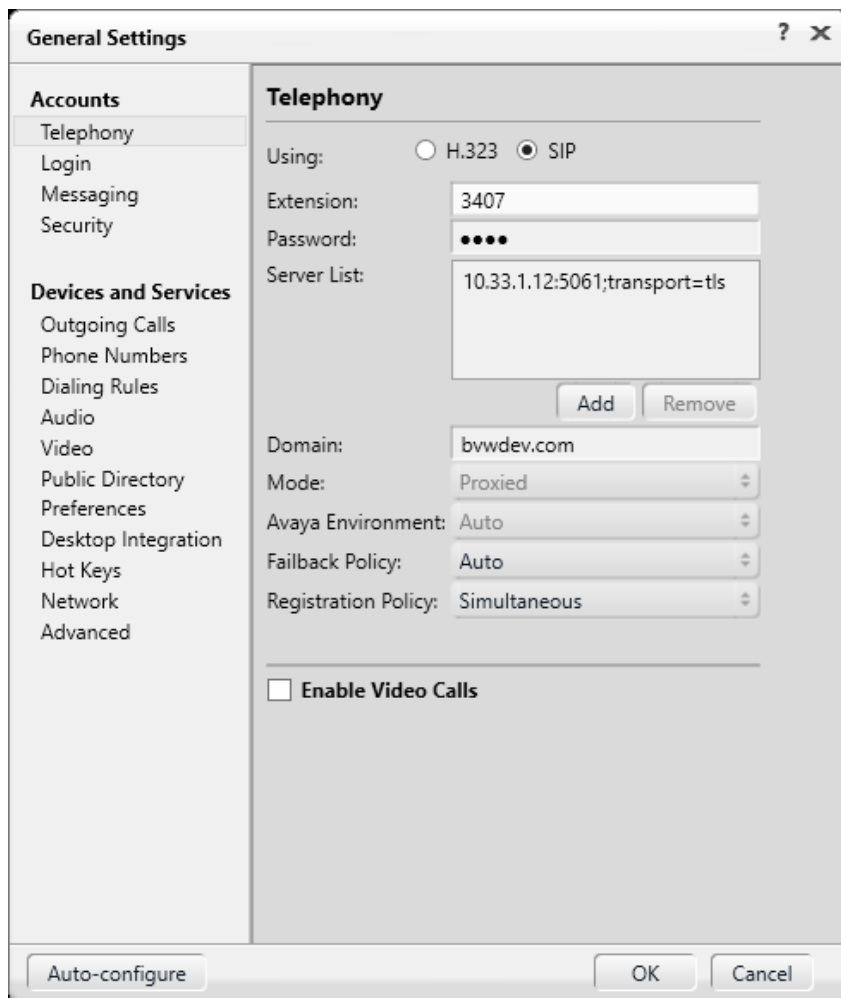
From the one-X Communicator window, navigate to the setting icon  → **Settings** → **Devices and Services** → **Audio** and select *Headset Microphone (Jabra Evolve 75)* and *Headset Earphone (Jabra Evolve 75)* in the **Microphone** and **Speaker** fields as shown below.



In case of Link 370 USB Bluetooth dongle being used, select the Link 370 values respectively as shown below.



From the one-X Communicator window, click  → **Settings** → **Accounts** → **Telephony** and enter the SIP user and password as configured in **Section 6**.



This window shows the one-X Communicator successfully registers to Session Manager.

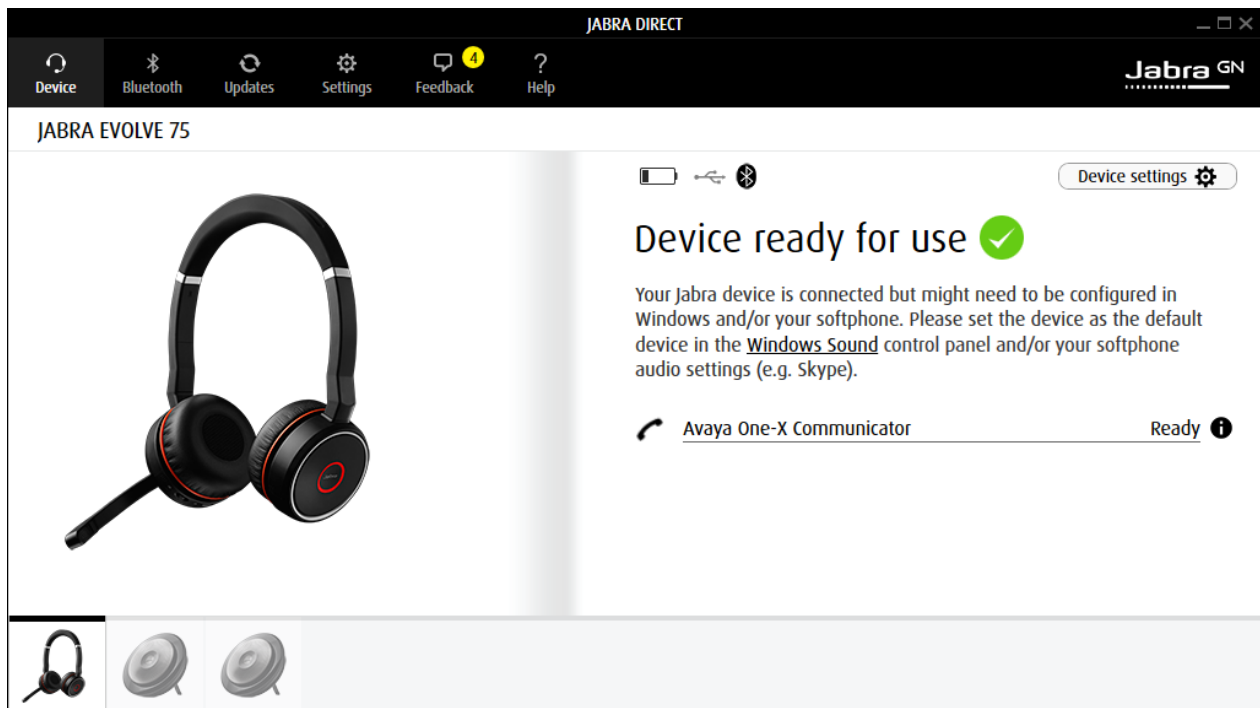


8. Configure Jabra Direct

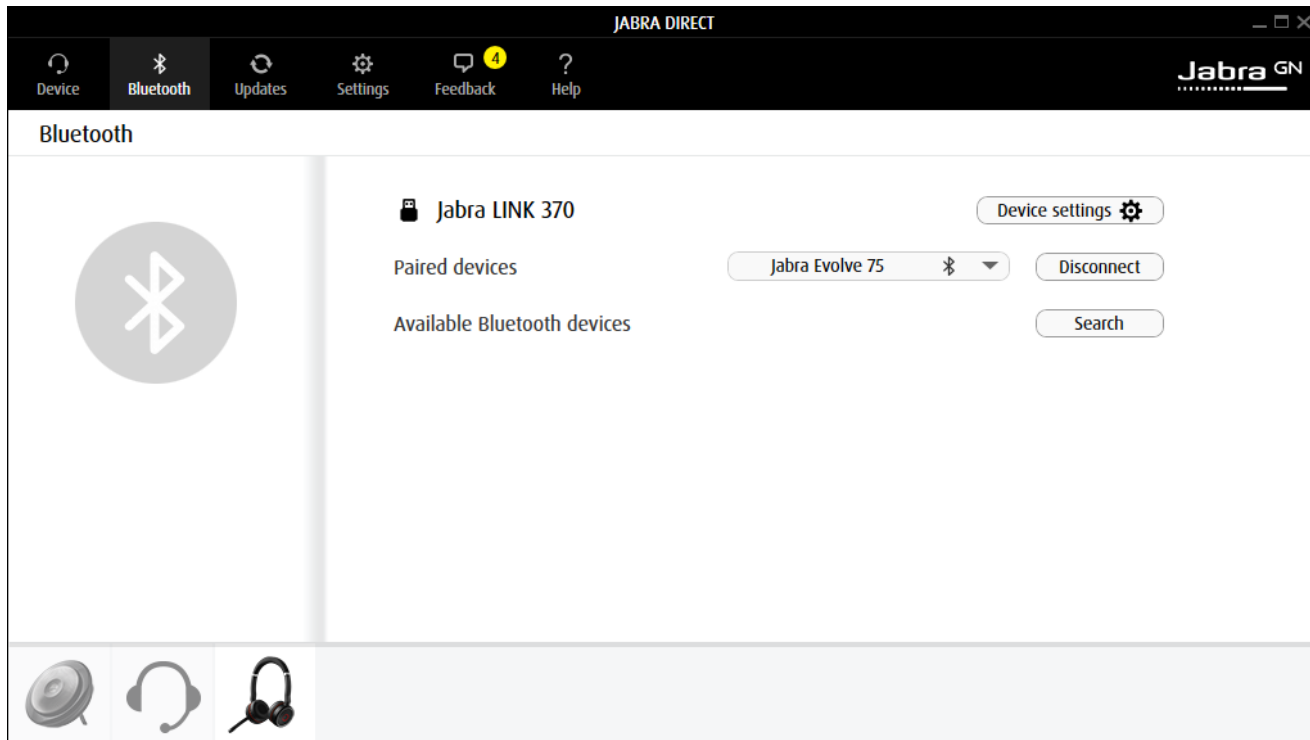
Direct is PC software that can be downloaded from Jabra website at <http://www.jabra.ca/software-and-services/jabra-direct>. Direct enables Evolve 75 to have call control over one-X Communicator. This section assumes Direct is already installed and updated to the latest version.

Direct automatically detects Evolve 75 and the connection method to the PC.

The picture below shows the **Device** tab in Direct dashboard having the Evolve 75 headset connected to the PC via USB Bluetooth dongle, it displays “Device ready for use” with one-X Communicator in **Ready** state.



The **Bluetooth** tab displays the Link 370 USB dongle that paired with Evolve 75.



9. Verification Steps

This section verifies that Jabra Direct and Evolve 75 UC Stereo Bluetooth/USB headset has been successfully integrated Avaya one-X Communicator.

1. Verify that the Evolve 75 headset has been successfully installed and is ready for use with the one-X Communicator.
2. Once the Evolve 75 headset is selected in the one-X Communicator, verify that incoming and outgoing calls can be established with two-way audio to the headset.
3. Verify that the Evolve 75 headset is able to control call functions from the headset such as mute/un-mute, hold/un-hold and disconnect the call.

10. Conclusion

These Application Notes describe the configuration steps required to integrate Jabra Direct and Evolve 75 UC Stereo Bluetooth/USB headset with Avaya one-X® Communicator. All test cases were completed successfully; refer to **Section 2.2** for details.
