# **Application Notes for Empirix Hammer On-Call Outbound Load Testing Service with Avaya Proactive Contact with PG230RM – Issue 1.0**

#### **Abstract**

These Application Notes describe the steps required for the Empirix Hammer On-Call Outbound Load Testing Service to successfully interoperate with Avaya Proactive Contact with PG230RM. The Empirix Hammer On-Call Outbound Load Testing Service was used to emulate real world conditions on the receiving side of outbound calls from Avaya Proactive Contact.

Information in these Application Notes has been obtained through DevConnect compliance testing and additional technical discussions. Testing was conducted via the DevConnect Program at the Avaya Solution and Interoperability Test Lab.

### 1. Introduction

These Application Notes describe the steps required for the Empirix Hammer On-Call Outbound Load Testing Service to successfully interoperate with Avaya Proactive Contact with PG230RM. The Empirix Hammer On-Call Outbound Load Testing Service was used to emulate real world conditions on the receiving side of outbound calls from Avaya Proactive Contact.

For the compliance testing, Avaya Proactive Contact placed calls over five PSTN numbers to the Empirix Hammer On-Call Outbound Load Testing Service. Each PSTN number was associated with a specific real-world condition, which included busy, ring no answer, special information tone for intercept, answering machine, and human answer.

Performance data from the test was published in real-time by Empirix to a secure web interface, and the reported data was compared with the data from the Avaya Proactive Contact Supervisor Analyst report.

These Application Notes assume the configuration and connectivity between Avaya Proactive Contact and Avaya Communication Manager is already in place and will not be described. Furthermore, the development and deployment of an outbound job on Avaya Proactive Contact to dial out to the five PSTN numbers to reach the Empirix Hammer On-Call Outbound Load Testing Service is outside the scope of this document. The focus of these Application Notes is on the customer deliverables that are required as input to the Hammer On-Call Outbound Load Testing Service, and the navigation of the real-time performance data output provided by Empirix.

# 1.1. Interoperability Compliance Testing

The interoperability compliance test included feature and performance testing.

The feature testing focused on verifying the feedbacks emulated by the Empirix Hammer On-Call Outbound Load Testing Service match the call classification by Avaya Proactive Contact. The feedbacks included busy, ring no answer, special information tone for intercept, answering machine, and human answer.

The performance testing included steady traffic for 30 minutes, and the performance data from the Empirix Hammer On-Call Outbound Load Testing Service was compared with the data from the Avaya Proactive Contact Supervisor Analyst report.

# 2. Reference Configuration




Figure 1: Empirix Hammer On-Call Outbound Load Testing Service with Avaya Proactive Contact with PG230RM

As shown in **Figure 1**, the compliance testing used Avaya Proactive Contact with the PG230RM deployment option to generate the outbound calls to the Empirix Hammer On-Call Outbound Load Testing Service. The results should be applicable to the Avaya Proactive Contact Standalone deployment option.




Figure 2: Avaya Empirix Outbound Contact Center Call Flow

The outbound call flow used for the compliance testing is shown in **Figure 2** below. Note that the actual PSTN numbers are masked in the call flow for privacy.

# Avaya Empirix Outbound Contact Center Call Flow

### 4. Customer Deliverables

In preparation for the load testing service, Empirix requires the following information to be provided by the customer at least two weeks prior to the actual test:

- Expected call behaviors
- Distribution of test cases
- Customer contact for test
- Customer contact for sign-off

# 4.1. Expected Call Behaviors

The specific interaction between Avaya Proactive Contact and Empirix Hammer On-Call Outbound Load Testing Service needs to be provided for every call scenario. An example is the call flow diagram shown in **Figure 2**.

#### 4.2. Distribution of Test Cases

The distribution for each call scenario needs to be provided to Empirix, and an example of the distribution is shown in **Figure 2**.

#### 4.3. Customer Contact For Test

A primary customer contact with knowledge of the application is needed to help answer any questions arising from the test planning and the actual test execution. This primary contact needs to be present during the test execution.

# 4.4. Customer Contact for Sign-Off

A customer contact with sign-off authority needs to be provided to Empirix for the load test.


# 5. Empirix Real-Time Performance Data

This section provides the procedures for navigating the Empirix Hammer On-Call Outbound real-time performance data from the load test. The procedures include the following areas:

- Access web interface
- Select test
- Review summary information
- Review errors
- Review call information


#### 5.1. Access Web Interface

Access the Hammer On-Call web interface by using the URL <a href="https://hoc.empirix.com">https://hoc.empirix.com</a> in an Internet browser window. Enter the **Username** and **Password** supplied by Empirix.




#### 5.2. Select Test

The Control Panel screen is displayed, select Outbound Tests.




The screen is updated with a list of tests along with test result information including duration of test, number of calls that passed/failed, total number of calls, and percent of calls that failed. Under the **Start Time** column, select a test to look into further.



# 5.3. Review Summary Information

The **Summary Info** screen is displayed next. This screen displays a graphical chart of average calls per minute versus errors per minute. The table below the chart displays the detail scripts that correspond to the call flow branches in **Figure 2**, along with statistical information.


Verify that the **Call Distribution** associated with each script below roughly matches to the distribution specified in **Figure 2**.



# 5.3.1. Verify Summary Information

From the Avaya Proactive Contact Supervisor PC, select Start > All Programs > Avaya > Proactive Contact 4.1 > Supervisor > Analyst to launch the Analyst application, and log in with the proper credentials.

The **Analyst** screen is displayed, as shown below. Expand **Job Reports** in the left pane, and select **Completion Code Summary**. Double click on the **Completion Code Summary** – **Today** entry in the right pane.



The Completion Code Summary – Today report is displayed. Verify that each completion code count below matches to the total calls for the appropriate script in Section 5.3. In the compliance testing, the CUSTHU and MANAGEDA completion codes below were entered by the answering agents.




#### 5.4. Review Errors

From the Hammer On-Call web interface, select the **Errors** tab to review the reported errors. The table below the chart displays the types of errors and the number of occurrences. The table shows that there were **12** detections of runtime exception with call disconnected for the **Play Answering Machine** script. This was due to Avaya Proactive Contact disconnecting the call before the entire answering machine message can be played. Note that modifications can be made on the Empirix Hammer On-Call Outbound Load Testing Service to enable shorter answering machine messages to avoid these calls being reported as failures.



## 5.5. Review Call Information

Select the **Call Info** tab to review the detailed call information associated with each call. Select a call of interest from the **All Calls** table, and the screen is updated with the details for the selected call. A **Listen to this call** link appears when the call has been recorded. Click on **Listen to this call** to listen to the recording of the call if desired. For the compliance testing, the majority of the calls were recorded due to the lower traffic volume. For testing with higher traffic volumes, not all calls may be recorded. Consult with Empirix representatives on the recording capacities.



# 6. General Test Approach and Test Results

Avaya Proactive Contact initiated outbound calls to the five different PSTN numbers corresponding to the different branches of the call flow. The feedback provided by Empirix for each PSTN number was verified manually to be properly classified by Avaya Proactive Contact.

The performance test cases were executed automatically with Avaya Proactive Contact generating steady traffic to occupy all outgoing trunks, and with two Avaya Proactive Contact Agents handling the human answered calls.

All test cases were executed and passed.

# 7. Conclusion

These Application Notes describe the configuration steps required for Empirix Hammer On-Call Outbound Load Testing Service to successfully interoperate with Avaya Proactive Contact with PG230RM. All test cases were completed successfully.
